**Town Council Regular Meeting  
Green Level Municipal Building  
Thursday, March 1, 2012**

The regularly scheduled meeting of the Town of Green Level Council was held on Thursday, March 1, 2012 at 7:00 PM in the Green Level Municipal Building located at 2510 Green Level Church Road.

**GOVERNING BODY MEMBERS PRESENT:** Mayor Larry McCollum, Mayor Pro Tem Michael Trollinger, and Council Member Carissa Graves.

**GOVERNING BODY MEMBERS ABSENT:** Council Member Remonia Enoch and Council Member Theodore Howard.

**GREEN LEVEL OFFICIALS PRESENT:** Town Administrator Haywood Cloud, Town Clerk Sandra McCollum, and Town Attorney Marissa West (Vernon Law Firm).

Mayor McCollum called the meeting to order and Mayor Pro Tem Trollinger gave the invocation.

**Town Administrator Updates**

The Administrator updated the Council concerning the new recycle contract with Waste Industries. The Administrator continued to say the grant was submitted to help with the cost for the recycle carts and he placed the order for the carts and they will be green.

The Administrator updated the Council that all of the violation at Otter Creek MHP have been corrected. The MHP has a new owner and the owner asked if he could board over the windows and paint the wood the same color as the trailer, because the new windows are been broken out as soon as he replace them. The Administrator stated that he will make sure the owner is doing what he needs to do to keep the MHP up to standards.

The Administrator reported that he had submitted the information to apply for the sewer project loan. The Mayor requested that the Administrator give copies of the information to Council Members, concerning the company that will be doing the engineer services.

Alex Winters, Parks & Recreation Director, presented a power point presentation concerning the recreational activities such as soccer games. He continued to say that he has not received any response of feedback from any of the contacts he called.

The Administrator stated that he contacted Haw River Parks & Recreation Director and asked if Haw River would be willing to use Green Level baseball field for their overflow of baseball tournaments. The Director said that he would consider using the field. The tournaments starts in April. The Administrator continued to say that there is help needed from the community.
