



**Town Council Regular Meeting  
Green Level Municipal Building  
Thursday, June 13, 2013 - 7:00 PM**

The regularly scheduled meeting of the Town of Green Level Council was held on Thursday June 13, 2013 at 7:00 PM in the Green Level Municipal Building located at 2510 Green Level Church Road.

**GOVERNING BODY MEMBERS PRESENT:** Mayor Larry McCollum, Mayor ProTem Michael Trollinger, Council Member Remonia Enoch and Council Member Carissa Graves.

**GOVERNING BODY MEMBER ABSENT:** Councilmember Theodore Howard.

**GREEN LEVEL OFFICIALS PRESENT:** Town Administrator Haywood Cloud and Town Clerk Sandra McCollum.

**GREEN LEVEL ATTORNEY PRESENT:** Marissa West (Vernon Law Firm).

Mayor McCollum called the meeting to order, Mayor ProTem Michael Trollinger gave the invocation.

**Public Hearing**

Mayor McCollum opened the Public Hearing for the 2013-2014 Budget. The Mayor asked the public if there were any questions or concerns about the budget? There were no questions or concerns. The Mayor close the Public Hearing. The floor was open for questions or comments from the Council Members. Mr. Bobby Massey, Town Accountant, made comments. There were no other comments, the Mayor asked for a motion to approve the 2013-2014 Budget. Council Woman Enoch made the motion to accept the budget as is, seconded by Council Woman Graves. The motion carried unanimously. (4-0)

Mayor McCollum asked for a motion to close the Public Hearing. Council Woman Enoch made the motion to close the Public Hearing, seconded by Council Woman Graves. The motion carried unanimously. (4-0)

**Town Administrator Updates**

The Administrator reminded the Council that the last time Mr. Mike Koser attended the Council meeting, there were some discussion concerning DENR about expanding the Otter Creek pump station or building a new one. A letter was received approving the improvements for the pump station with a zero per cent interest. Mr. Koser will attend the July meeting with his updates.

The Administrator informed the Council that the Summer Food Program will be Monday, Wednesday and Friday, starting Monday July 8, 2013. The Administrator continued to say that he, the Code Enforcer and Park Director had to attend a class to be approve for the program. The Administrator replied that this time of the month is tricky to have the program because the children in Green Level go to year round school. Council Woman Enoch asked how is the information being circulated about the program? Bernard Johnson replied that he is distributing flyers at different stores and the Administrator replied that the information will be sent out with the Day In The Park flyer. Council Woman Enoch replied that she have not seen any information about the program.

The Administrated stated that Bernard Johnson would give the update on the Day In The Park. Mr. Johnson replied that Mrs. Ann Brooks, Recreation Committee, gave the Council information on what she have gotten donated for the event. Mr. Johnson continued to say that there have not been a lot of money spent for the event.

Mr. Johnson reported that the football camp and registration will be in July. Council Woman Enoch asked if fans (paper-hand held) could be purchased for the Day In The Park and maybe some of the donators that donated supplies for the event can be placed on the fan.

The Administrator addressed the Council about a new building for the Town Hall. The Town Clerk gave the Council members a proposal for a new building. A power point presentation was presented with pictures of a building that could possible be a town hall. The Administrator stated that the current building will be check for asbestos. Pro Tem Trollinger stated that Alamance County EMS is interested in having a base set up between Alamance County and Caswell County and maybe they could talk to the Council about having the base at this building and this would help with the cost of the new building. Pro Tem Trollinger continued to say that he do not want to just have a building with no vision. The Mayor responded that the structure will have to be affordable. The Administrator stated that this was something for the Council to think about.

**Council Discussion**

Pro Tem Trollinger asked about the updates on mowing residents yards. The Administrator replied that Public Works have mowed six yards. He continued to say that the Attorney is asking the County about how the Town can get the money back. Pro Tem Trollinger asked if the Town could put the mowing up for a contract job? The Clerk replied that it was suggested to the prior Mayor and Council and this was voted down because the charges for contractors were expensive and the Town would not recoup the money. The Mayor stated that he thinks that this would not work.

Council Woman Enoch thanked everyone for their help to organize the Day In The Park event and hope to see the Council Members there. She continued to ask Mr. Johnson did he get the baseball program going? He replied, no.

Council Woman Enoch stated to the Administrator that she had come by last month to pay her water bill and Hazel Walker, Town Secretary, was still at work at 7:30 and previously she have seen her car still in the parking lot after 7:30. She continued to say that she was concerned about her safety.

Council Woman Enoch stated that since the Council is meeting once a month, she would like to see each department come to the meetings to give their reports on what they are doing.

Council Woman Graves stated that since the last meeting, she married and is now Carissa Graves-Henry. She introduced her husband.

Mayor McCollum - No discussion.

There being no further business.

The Mayor asked for a motion to adjourn the meeting. The motion was made by Council Woman Enoch, seconded by CouncilWoman Graves-Henry. The motion carried unanimously. (4-0)
