NOTICE TO THE PUBLIC

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER




PAYMENT ARRANGEMENTS

The Governor will not be extending the utility shutoff moratorium created by Executive Order 124. The moratorium ended July 29, 2020 as scheduled. For the Town of Green Level, this means the \$12 late fees will be accessed on August 15th, cut off fee of \$20 will be accessed on August 26th and accounts that are not paid in full at close of business on August 25th will be on the cut off list for non-payment. Exceptions to the shut off will be:

- Customers with payments in the dropbox at 8:00am on August 26th when the Utilities staff arrives
- Customers whose payments are received from the post office posted marked 8/25/20 at pickup at 8a.m on August 26th
- Customers who have entered a signed payment agreement before 5:00pm on August 25th to pay the balance incurred during COVID-19 (March 25th-July 29th) over 6 months (or more)
