REMINDER FROM CODE ENFORCER



To build a deck, fence, carport, gazebo, or addition to your home you **must** obtain a permit from Town of Green Level! Send in a complaint form to report grass higher than 12 inches, junked cars, trash piles, etc. Forms available online at:

www.greenlevelinc.com. Click on Departments, Code Enforcement, then submit the appropriate forms. Forms are reviewed on Tuesdays and Thursdays.

PAYMENT ARRANGEMENTS



For those residents who have signed a payment plan agreement due to financial hardships related to COVID-19, please remember your second payment, in addition to your August bill, per the payment plan is due on September 15 or on the agreed upon date. Should payment not be received, your water will be turned off. A cutoff fee of \$20 will be assessed onto your account and consequently, to reactivate your water account, payment of the \$20 late fee and the entire remaining balance will be due. Please contact the Utility Department should you have any questions. Exceptions to the cut off list will be:

- Customers with payments in the dropbox at 8:00am on September 28th when the Utilities staff arrives
- Customers whose payments are received from the post office postmarked 9/27/20 or earlier at pickup at 8:00a.m on September 28th
