Code Violations

Here are a few Code Violations that should be corrected on properties here in the Town of Green Level, for residents to avoid further action.

-Junked, inoperable, unregistered, dismantled vehicle(s)

- It shall be unlawful for the registered owner or person entitled to the possession of junked motor vehicle for the owner, lessee, or occupant of the real property upon where which a junked vehicle is located to allow the junked vehicle to remain on property after vehicle has been ordered to be removed from the property.
- It shall be unlawful to have more than one junked motor vehicle, upon the premises of public or private property.

-Trash left on property

- **Regular Trash:** will be placed in Town approved garbage containers and placed on the curb to be picked up on Monday.
- **Bulk Trash:** will be picked up by Appointment Only! To be placed on the Bulk Schedule you must call (336)578-3443 no later than 2 pm on the day before the scheduled Bulk pickup.

-Grass should not be 8 in. or taller.

-Any worn-out, deteriorated or abandoned household or office furniture, appliances or similar products should not be kept in open space which is open to the exterior, **such as carports, porches, and any other exterior portions of the property.**
